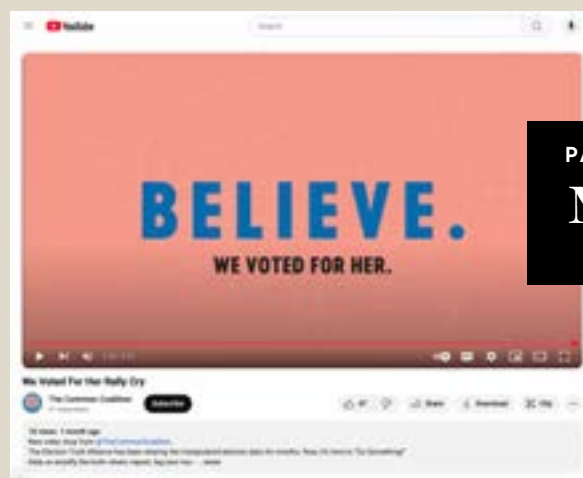

Subject: Call for Hand Audit of 2024 Election Results

Dear **[REPRESENTATIVE NAME]**,

My name is **[FIRST AND LAST NAME]**, and I am reaching out to you from **[YOUR STATE]** to call on you to undertake a hand audit of paper voting records from the 2024 general election in **[SWING STATE]**.

I've recently been made aware of significant anomalies in the 2024 U.S. Presidential election results data. The Election Truth Alliance (ETA), a non-partisan, non-profit organization, has undertaken independent analysis of election result data and has raised significant concerns about these data anomalies, including that these patterns may be consistent with signs of vote manipulation. "Vote manipulation" can mean adding, deleting, or flipping votes.

I have deep concerns that the constitutional rights of my fellow Americans in **[SWING STATE]** may have been disenfranchised. Given **[SWING STATE]**'s significance in determining the outcome of the 2024 Presidential election.

#1: Since inauguration, the Executive Branch has not been governing in a way that appears concerned with future electoral consequences. If vote manipulation occurred in 2024, I fear that every primary, midterm, and Presidential election in future may be decided behind closed doors instead of by “we the people.”

#2: My concerns are elevated by remarks made by the then-President Elect at a Washington, D.C. rally on January 19, 2025 regarding Elon Musk’s familiarity with “vote-counting computers” and how that knowledge may have impacted the 2024 election. Without a hand audit to confirm the reported results, I am deeply concerned that these type of remarks, combined with statistically unusual election results, could continue to undermine American confidence in the legitimacy of our elected leaders.

#3: When election integrity concerns were raised after the 2020 election, recounts were held in at least three swing states (Arizona, Wisconsin, and Georgia) and over 60 lawsuits were filed to challenge results. In 2024, no recounts took place at the Presidential level.

#4: We know from the findings of past bipartisan U.S. Senate Select Committees that America’s electronic voting infrastructure is vulnerable to interference, and that foreign adversaries have previously attempted to manipulate our elections. Our country should be governed by individuals elected by Americans to be their leaders, not installed by our adversaries in an attempt to weaken our country.

Knowing this, I am writing to strongly urge you to undertake a full hand audit of paper voting records from the 2024 Election in **[SWING STATE]**. There is no better use of government time and resources than to ensure the will of the people is respected, and to ensure that your constituents – and all Americans – can have confidence in the integrity of our elections.

I am contacting you to demand a full audit of the 2024 general election, including hand recount audits of paper ballot records. A non-partisan, grassroots organization called the Election Truth Alliance has conducted analysis of the election results and has identified irregularities suggesting possible vote manipulation across multiple states. I have valid concerns that my vote may not have been counted accurately. Please reaffirm my confidence in our elections by conducting a thorough forensic audit of the 2024 general election to investigate these irregularities. Thank you.

Version 2: Moderate Urgency

I am urgently calling on you to investigate these abnormal findings with an audit of the 2024 general election, including hand recount audits of paper ballot records. Thank you.
