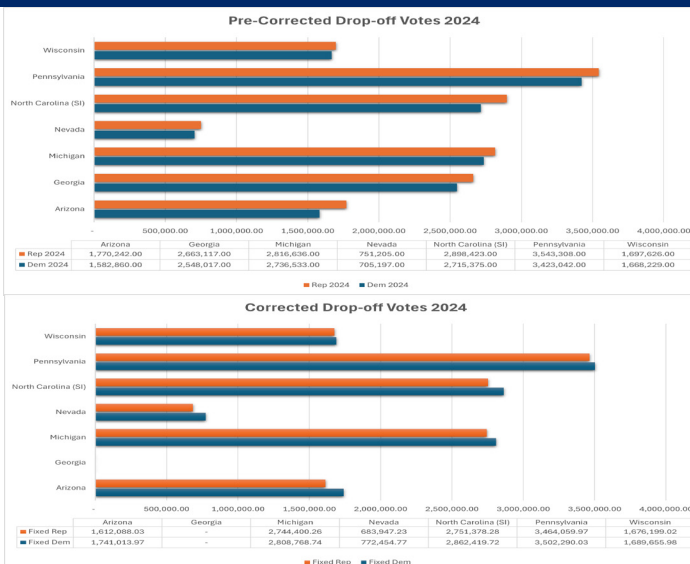
Estimate Of Potential Vote Change

The average overperformance of Candidate Trump outside the 7 swing states is approximately 2%.

If additional overperformance above 2% in the swing states was caused by a vote changing algorithm, then returning those votes would see Candidate Harris winning in 6 of the 7 swing states this calculation can be conducted for.

The potential number of votes changed would be close to 1.5million.

This is not including any voter suppression such as mail-in ballots never being delivered.

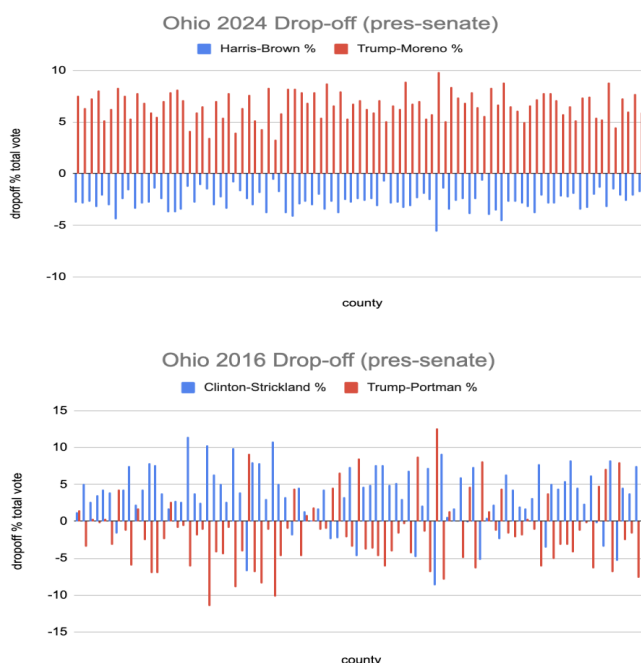


Manipulation 2024: Ohio Drop-Off Vote.

In 2024, we see concerns of vote manipulation when graphing the drop-off vote rate by county.

This consistent voting result across an entire state is concerning, given that a human voting pattern looks more like 2016's results for Ohio.

This would be evidence of vote manipulation, removing votes for Candidate Harris and giving them to Candidate Trump.

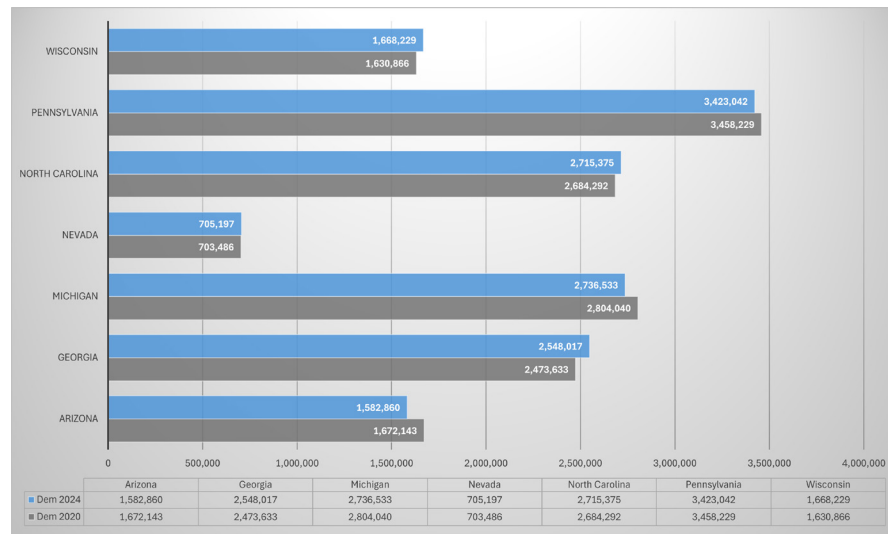


Candidate Harris Performance

Averaged across all 7 swing states Candidate Harris received 99.6% of Biden's votes from 2020.

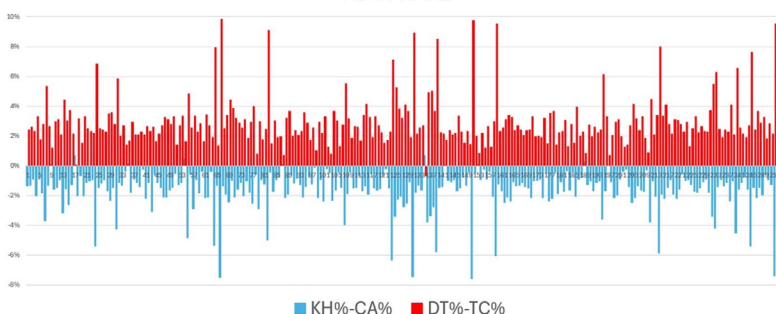
This highlights concerns for why Candidate Harris would be underperforming significantly while still retaining the party base.



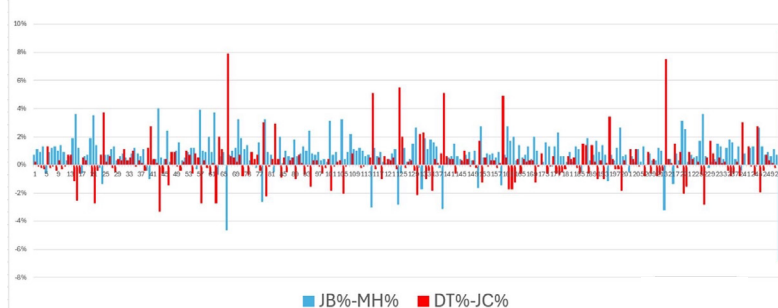

"The 2024 down-ballot data across all swing states and Texas reveals voting patterns that are inconsistent with typical human behavior. In county after county, one candidate consistently over performs their party's down-ballot candidates by a similar percentage, while the opposing party's candidate underperforms by a nearly identical margin. These anomalies are not present across all states or voting methods, but appear isolated to specific ones. This uniformity is especially concerning, as it deviates from expected voter variability and aligns closely with the statistical footprint of a top-of-the-ticket vote-flipping algorithm." – **ETA Statisticians**

Widely regarded as the **leading U.S. expert in election forensics**, Dr. Walter Mebane, Jr.'s analysis using the 'eforensics' method has identified an estimated 225,000 fraudulent or distorted votes, in which 111,088 of those were identified with high confidence as **intentional, malevolent manipulations**.

It raises serious questions about the election outcome.

Given that **the margin of victory was approximately 171,000 votes**, this narrow differential raises substantial questions concerning the integrity and outcome of the election.

This percentage reflects the lowest, most conservative estimate possible.

Summary of Dr. Mebane's eforensics model of Estimating Fraudulent Votes

- Mebane characterizes "election frauds" as **malevolent distortions of voters' intentions** that change, or potentially can change, election outcomes.
- Election frauds therefore **thwart the accurate reflection of voter intention**.
 - This is different from procedural failures in administering an election, or from unintended accidents such as a machine malfunction.
 - This thwarting may result from undemocratic actions, such as actions undertaken by authoritarians.
- The intent of Mebane's eforensics model is to detect "realized frauds," not procedural frauds. Specifically, the intent of the model is to estimate **how many votes are misdirected or misallocated due to malevolent distortions of electors intentions**.
- Measuring election frauds comes with fundamental ambiguities. Voters' intentions are not observable, and in politics people act not merely based on what they prefer, but also on what they expect other people to do through strategic behavior.
- The estimates produced by the eforensics model are characterized by Mebane as **valid, though imperfect**. The model is intended to be inclusive of malevolent distortions of voter intent that may not be detectable through post-election audits.

A Multi-Pronged Strategy

Multiple avenues exist through which the 2024 election was compromised—each pointing to a coordinated, long-term strategy to manipulate outcomes in key states.

1. Illegal Access to Voting Equipment

Had District Attorney Fani Willis not been blocked by a questionable decision from a partisan GA appeals court, Americans would have seen compelling evidence that Trump's associates used the "Big Lie" narrative to gain [unauthorized access to election equipment](#) in Michigan, Georgia, Pennsylvania, Arizona, and Colorado. In some instances, **machines were taken to hotels for "inspection."**

Tina Peters, the Colorado official who facilitated this access, was sentenced to **nine years in prison**.

2. Coordinated Election Disruptions via Threats

According to the [Brennan Center](#), **at least 227 bomb threats** targeted Democratic polling locations, election offices, and tabulation centers nationwide on and after Election Day. **Explosive devices detonated on ballot drop boxes** across several Pacific Northwest states, and law enforcement was deployed in response to several hoax calls reporting active shooters at schools serving as polling sites in the Northeast.

3. Corporate Acquisition of Election Infrastructure

In 2021, Tripp Lite—a company certified to maintain over **70% of U.S. election equipment**—was sold by far-right judicial architect [Leonard Leo to Eaton Corp.](#)

Eaton Corp had previously partnered with Palantir, co-developing AI-driven supply chain systems, effectively linking Peter Thiel to the nation's voting infrastructure.

By 2024, Eaton [expanded its work with Palantir](#) to include AI powered management, migration, and cleansing of large datasets—raising questions about the potential application to sensitive election data.

Then, just **two months before the election**, [Eaton entered a strategic partnership with Tesla](#) to supposedly streamline home energy deployments—integrating Eaton's infrastructure into Elon Musk's corporate web, providing cover for financial and technological coordination.

4. Data Harvesting and Algorithmic Manipulation

Just 90 days before the 2024 election, Musk launched a voter information harvesting PAC exclusively targeting swing states, paying up to **\$1 million per day** to entice registration.

Staff from Musk's DOGE initiative—notably **Ethan Shao**—developed a platform called [BallotProof](#) in 2020, marketed as a ballot scrubbing tool.

The combination of BallotProof, mass data harvesting, and the [vote-flipping algorithm](#) observed in **swing state data** raises critical red flags.

Millions of voters supposedly did not vote in 2024, however, social media accounts for an untold number of voters came forward stating they DID vote—but records show they didn't. **These votes were likely scrubbed or tossed** out of the system.

5. Satellite-Based MitM Interference

In January 2024, Musk began [rapid deployment](#) of a low-orbit **Direct-to-Cell satellite constellation**, with **265 satellites** operational by late October. These satellites have the ability to function as a man-in-the-middle (MitM) network, the equivalent to **placing a Stingray device above every voting precinct** in America.

This unprecedented infrastructure **raises urgent cybersecurity concerns**, particularly due to its potential for intercepting or redirecting election-related transmissions. With this technology, **the argument that "election equipment isn't connected to the internet" becomes irrelevant**—data packets can be wirelessly intercepted and relayed via DTC satellites.

6. Disinformation Campaigns on X

As described in [this Substack](#) by a former X employee, "We completely changed how the algorithm worked, **pushing pro-Trump and right-wing posts to the top of people's feeds**. To make it look balanced, we also boosted some left-wing critics of Democrats, but it **was all carefully calculated.**"

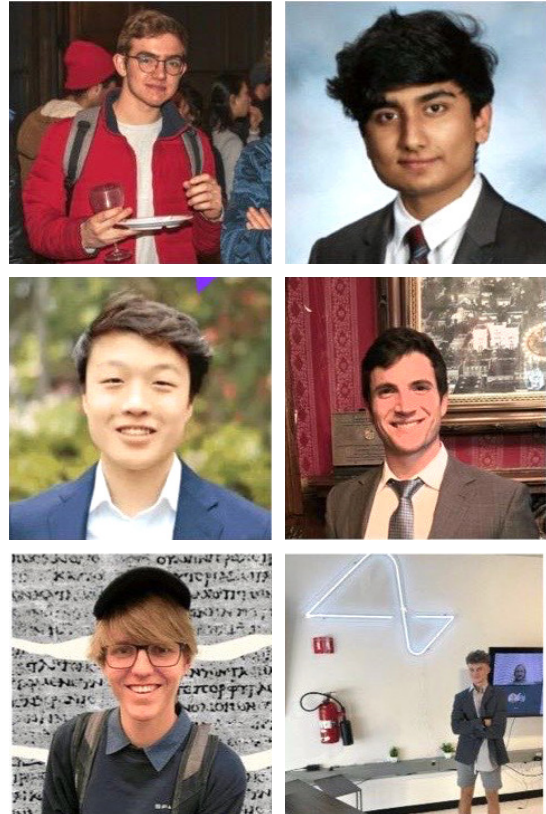

Meet the hackers who made this possible.

The so-called “DOGE boys,” long-time employees at Elon Musk and Peter Thiel’s beck and call, are not just meme-loving tech enthusiasts—they’re **highly skilled technology engineers** with deep access to sensitive infrastructure.

Among them, **Ethan Shaotran** stands out most, having **developed a platform called BallotProof**, ostensibly designed to scrub and validate ballots. While marketed as a tool for election integrity, in the wrong hands—or under the wrong orders—it could be repurposed **to manipulate or hijack election outcomes** under the guise of verification. Their proximity to Musk and unfettered access to critical systems should raise serious alarms.

Time is of the essence—we **no longer have the luxury of performing lengthy post-election audits** to determine whether criminal activity occurred. What we do have time for are investigations into Elon Musk, his DOGE boys, BallotProof, and how [he had access](#) to election results four hours before polls officially closed.

The Palast Report: Trump Lost. Vote Suppression Won.

Investigative journalist Greg Palast has extensively reported on voter suppression in U.S. elections, particularly highlighting its impact on the 2024 presidential race.

Greg Palast's findings detail several mechanisms of voter suppression in the 2024 election:

Voter Roll Purges: Approximately 4.78 million voters were reportedly removed from registration databases, often without adequate notice or justification. [Read More.](#)

Mail-In Ballot Disqualifications: Over 2.1 million mail-in ballots were disqualified due to minor clerical errors, such as missing signatures or postage issues. [Read More.](#)

Provisional Ballot Rejections: Around 1.2 million provisional ballots were rejected, frequently affecting voters who faced challenges at polling stations. [Read More.](#)

These [suppression efforts](#) disproportionately impacted communities of color. For instance, studies indicated that Black voters were up to four times more likely to have their mail-in ballots rejected compared to white voters.

Doesn't that make more sense?

Based on what has been observed as a threshold-triggered shift in the data, **a vote-flipping algorithm switched votes from Kamala Harris to Donald Trump**. Outside the seven swing states, Candidate Trump's average overperformance relative to down-ballot races hovers around 2%. Correcting the excess overperformance in the swing states—as a result of a vote-flipping algorithm—shifts the outcome to Kamala Harris in six of the seven swing states. (Note that GA data is not yet analyzed).

The estimated number of altered votes is approximately 1.5 million, not including the effects of voter purges, undelivered mail-in ballots, or disqualifications over minor clerical errors.

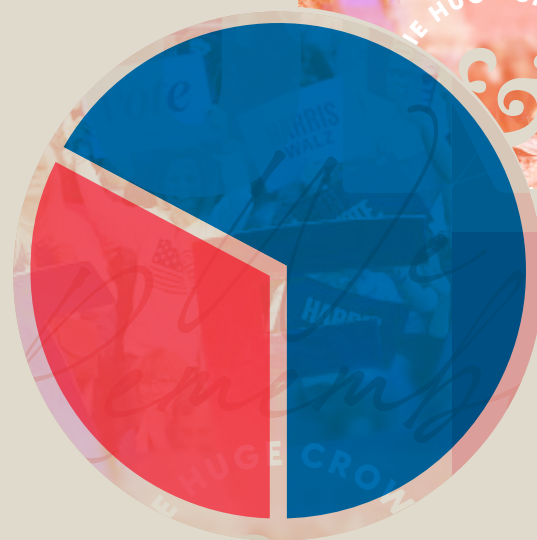
State-level suppression laws, such as [GA Gov Brian Kemp's SB 202](#)—which **cut drop boxes by 75% in Black-majority counties** and limited access to business hours—**reduced Democratic drop-off and mail-in voting by nearly 90% in 2024 compared to 2020**.

Forensic election expert Greg Palast estimates that at a minimum, **3,565,000 votes were suppressed from Harris**, and would present this in his role as a forensic expert as “the lowest conceivable suppression factor.”

Taken together, **the data indicates Kamala Harris won six of the seven swing states plus Texas**—including Georgia's suppression effects, **Kamala Harris (would have) secured a decisive 359–179 electoral college victory over Donald Trump**.

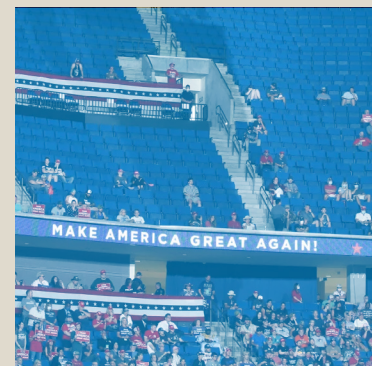

An overwhelming number of registered [Dems didn't receive requested mail-in ballots](#) in red states.

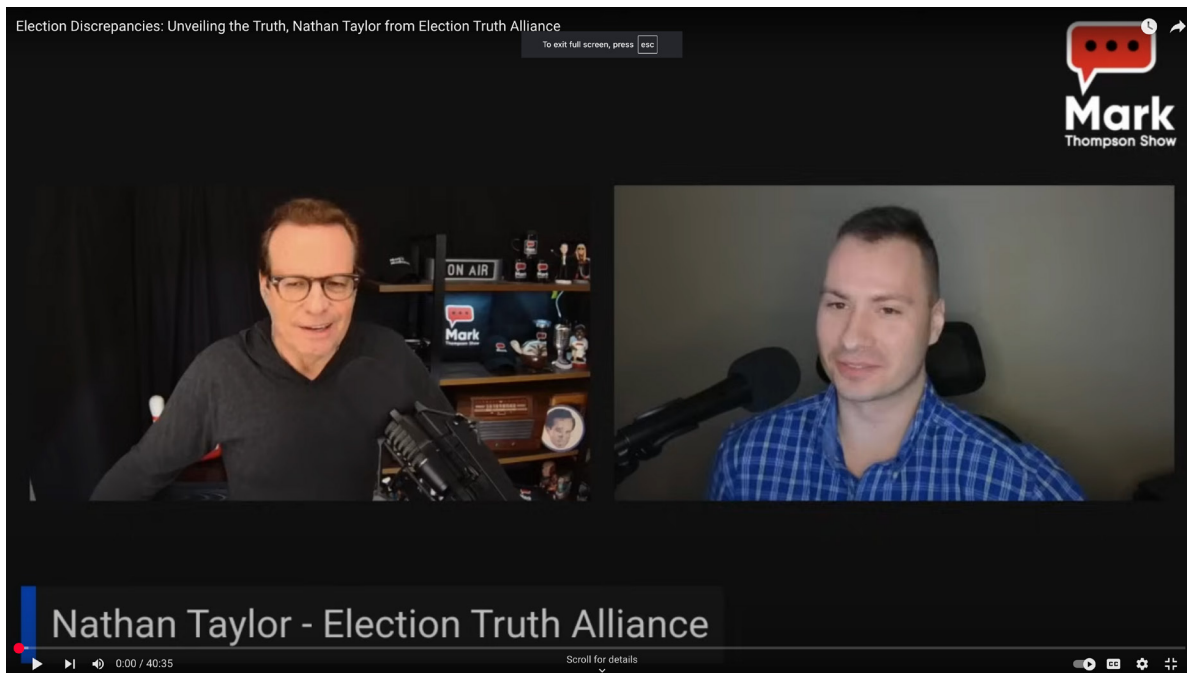

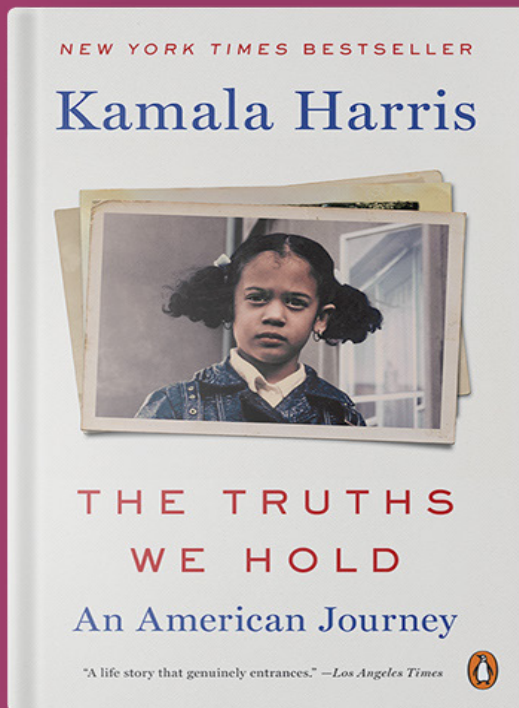

To be clear: those denying the 2020 election results lost all 64 court cases—many due to lack of standing, but fundamentally because they had no evidence.

Fox News was forced to pay Dominion \$787 million for knowingly spreading falsehoods about the 2020 election. Tucker Carlson was fired for his direct role in promoting those lies. [The Smith report](#) confirms that **Trump and his cabinet were well aware they had lost—before November 15, 2020.** Governors in key swing states called Trump directly to confirm his defeat. **Despite this, Trump and his team pushed the "Big Lie,"** deliberately inflaming the MAGA base.

In a typical impeachment scenario, yes. But that's not what we're navigating—leaving Peter Thiel's Build-a-Bear in office is simply not an option.

Impeachment is far too narrow a remedy. It targets a single individual and hinges on political will—which we've already seen collapse twice under a corrupt and complicit GOP.

Even if it were successful, it would remove Trump while leaving behind the others who enabled—or actively participated in—the same antidemocratic agenda.

Because **what is a stolen election, if not a coordinated act of rebellion** against the very foundation of our constitutional government?

We have constitutional mechanisms to remove this illegitimate, unelected administration. And **we have a Congress full of lawyers who swore an oath to protect that Constitution.** It's time they get to the protecting part.

The Vice President's stance on the Israeli-Palestinian conflict—while a valid subject—should not discredit credible concerns regarding election interference.

We want to correct a few key points of misinformation. **First, stop blaming the Free Palestine movement for Trump's so-called "win." Kamala Harris won.** Millions of our neighbors opposed U.S. weapons funding under the Biden-Harris administration—but they still understood the stakes and voted accordingly. They cast their ballots to defeat Trump, knowing that protests for an arms embargo would continue under Harris, a President who would not punish them for speaking out. **These voters are not your enemy.** They are some of the most passionate allies in our shared fight for justice.

Second, we want to name the **propaganda, lies, and smear campaigns that were deployed**—this time branding Vice President Harris as a supporter of genocide. Putin's well-documented use of psychological "active measures" to destabilize democracies was on full display—with xenophobic and racist narratives pushed by Trump, his sycophants, and other bad actors. [These attacks were strategically designed to divide the base](#) and erode support for Kamala Harris. And what better platform to carry it out than "X," Elon Musk's so-called public square—which he promptly transformed into a pro-Trump, Russian propaganda dumpster fire.

Regardless—they failed. The data shows disinformation alone wasn't enough. They had to deploy a vote-flipping algorithm to fabricate a 'win.'

Lastly, we acknowledge that **VP Harris repeatedly called for a ceasefire**, expressed support for a two-state solution aligned with the will of the majority on both sides, and made clear her condemnation of war crimes. The Biden-Harris transition prioritized defeating Donald Trump with a plan to confront the Netanyahu government's policies immediately after the election.

We cannot let internal divisions distract us from the threat of an authoritarian movement willing to burn democracy to the ground in their efforts to seize power.

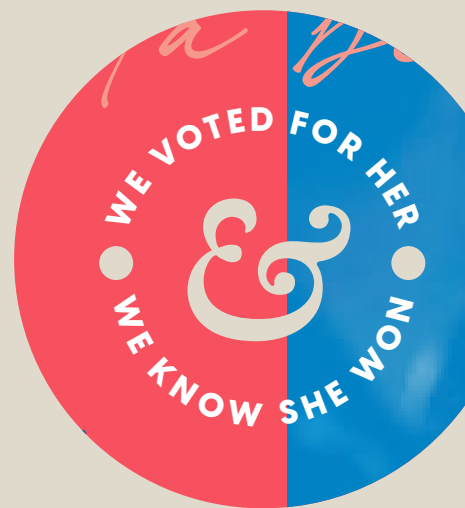

This Will Hold

Section 3 of the 14th Amendment was written precisely for this moment.

Stealing an election is a rebellion against the Constitution.

"No person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability."

It only takes one member of Congress to recognize the disqualification.

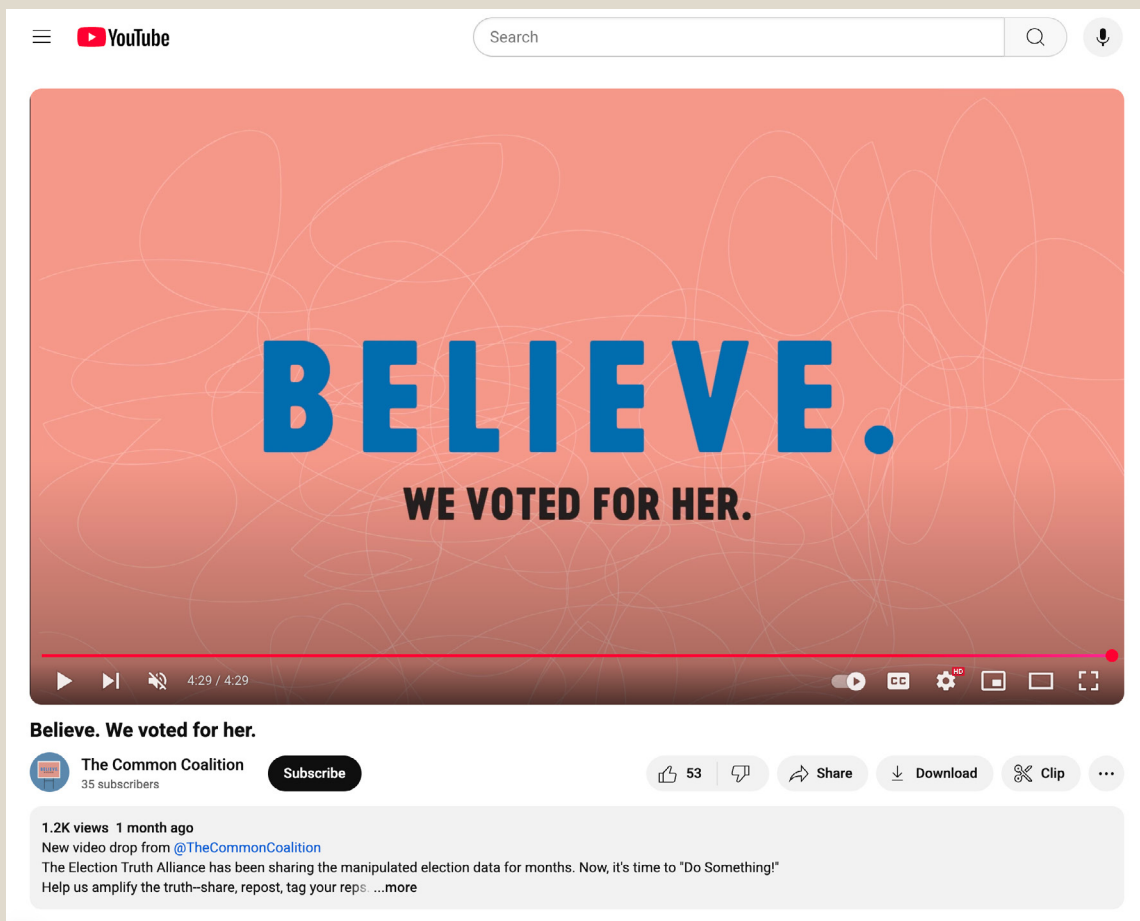

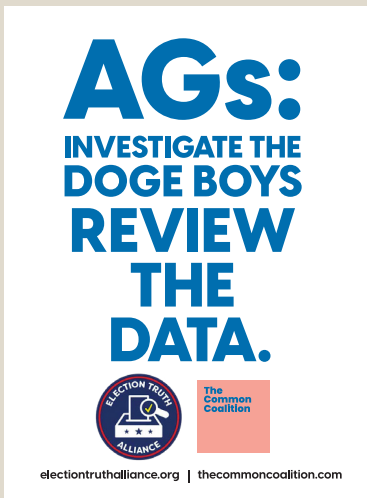

Final Statement.

We must secure the midterms.

At its heart, we have a hopeful message—but we have to be honest: the Democratic Party has been falling short for a long time, especially when choosing between what's right for the people and the optics.

The **GOP hasn't produced a legitimately elected president since Eisenhower**. Think about that. Nixon, Reagan, Bush II, and Trump all came to power through colluding with foreign governments or a compromised Supreme Court bench—Trump did both. And the Democrats never held them accountable. Trump is not Nixon, Reagan, or Bush—**we cannot ride this out for four years** hoping for a pendulum swing at the midterms. We know better.

The **amount of suffering that could have been mitigated or even avoided**—had Democrats intervened when they knew power had been gained through malfeasance, is staggering. Women of color are tired of carrying water for a party that continues to hand us a bucket full of holes. Any party that chooses authoritarianism—whether out of fear or a desire to retain power—is unfit to lead.

Over 70% of voting equipment is compromised, and we've already seen what that looks like in key states. Despite historically low approval ratings, Trump has the audacity to project a midterm sweep. He claims blue states will "totally disappear off the map" and says he has a "big, big surprise." And we know why—the election equipment is cooked.

Bottom line: it's incumbent upon us to help the American people understand, **we no longer have the luxury of time**—and the institutional **Democrats no longer have the option of comfortable cowardice**.

We have constitutional avenues to remove this illegitimate administration. First, **the public must know the truth** about what happened on November 5—so they can demand that legislators do the right thing. Tell Congress it's time to fulfill its most essential duty: **To protect the Constitution and the people it serves.**
